This certification is made pursuant to Section 25C of the Internal Revenue Code \*\*\*

The products listed below are advanced main air circulating fans that account for no more than 2% of a furnace's total energy use and meet the definition of "Qualified Energy Property" in Section 25C of the Internal Revenue Code (IRC).

If the products listed below are installed together with a natural gas, propane, or oil furnace that also meets the definition of "Qualified Energy Property" in Section 25C of the IRC in the homeowner's primary residence and placed in service from January 1, 2009, through December 31, 2010, then the homeowner may qualify for a non-refundable tax credit under Section 25C of the IRC, as amended by the American Recovery and Reinvestment Act of 2009. The amount of credit is capped at 30% of the installed cost of both the advanced main air circulating fan and the natural gas, propane, or oil furnace, up to \$1500.

If the products listed below are installed together with a natural gas, propane, or oil furnace that does **not** meet the definition of "Qualified Energy Property" in Section 25C of the IRC, then the homeowner may still qualify for a non-refundable tax credit under Section 25 C of the IRC as amended by the American Recovery and Reinvestment Act of 2009, provided that the advanced main air circulating fan and natural gas, propane, or oil furnace were installed in the homeowners primary residence and placed in service between January 1, 2009 and December 31, 2010. Under these circumstances, however, the homeowner may only receive a non-refundable tax credit for the installed costs of the advanced main air circulating fan, **not** the natural gas, propane, or oil furnace. Advanced main air circulating fans and natural gas, propane, or oil furnaces are usually installed at the same time and not separately invoiced, so the homeowner may estimate the installed costs for the advanced main air circulating fan as 8.7% of the installed cost of both the advanced main air circulating fan and the natural gas, propane, or oil furnace, in order to claim the non-refundable tax credit.
